Dates and time Monday October 29 10 am - 2 pm to the **Sacramento Fine Arts Center**, 5330-B Gibbons Drive, Carmichael, CA 95608. (Arrangements can be made to deliver Sunday evening 5 to 6 prior to the Monday receiving.)

ELIGIBILITY:

Open to all artists. Work must be original, not previously shown at SFAC.

ALL ARTWORK MUST BE FOR SALE. (SFAC sponsored exhibits only)

EXHIBITION SPECIFICATIONS:

Submit only recent work, finished within the last two years. All 3D art eligible, assemblage, ceramics, sculpture, carving, including 'on the wall' 3d art, etc. Place name, title, price, phone number on or under sculptures. Sculptures over 50 lbs. are to be installed & reinstalled by artist. Installations must meet fire and safety codes and free standing work stable and safe for viewing. Chosen works and award winners are solely at the Judge's discretion.

LIABILITY:

The Sacramento Fine Arts Center will be diligent in care of artwork but is not responsible for loss or damage that might occur. Insurance is the responsibility of each artist

COMMISSION:

SFAC will retain commissions on work sold. 50% for nonmembers, 30% members.

REMOVING WORK:

Accepted work must remain for the duration of the show and will only be released at end of exhibit at 5:00 pm November 18. Remove work not chosen by the judge during gallery hours, 11:00 pm–3:00 pm.

STORAGE FEES:

Work left after one week after exhibit closes will be assessed \$5.00 per day per work. Work left after one month, becomes property of the Sacramento Fine Arts Center.

ACCEPTED, NOT ACCEPTED AND AWARDS

Notification of acceptance will be available on the SFAC website SacFineArts.org after judging and before installation

AGREEMENT: I have read and agree to abide by all exhibit rules. I waive any and all claims against the Sacramento Fine Arts Center and individuals associated with the exhibition. Submitted art is my original work and has never been shown at SFAC. My work will be removed Sunday, November 18 between 5 pm and 6:00 pm or the week following the exhibit during Gallery Hours.
