January 2-3, 11 am-3 pm. to the Sacramento Fine Arts Center, 5330-B Gibbons Drive, Carmichael, CA 95608. Arrangements may be made to deliver your work early call or email us.

**ELIGIBILITY:**

Open to all paid 2019 member artists. All media. Work must be original, may not be previously shown at SFAC. No copies of published work, no class or work-shop work, crafts, videos, film, or work produced by commercial printing processes (exception: photography) No Giclees

**EXHIBITION SPECIFICATIONS:**

Submit only recent work, finished within the last two years. Work with glass must have rigid gallery style framing. We suggest plain frames with neutral mats. Work exceeding 29" X 35" (1015 sq. inches) must use plastic. No unfinished canvas edges, protruding nails, staples or saw-tooth hangers. Use braided wire or strong plastic line and flat brackets instead of screw eyes to attach wire. Tape wire ends. Diptychs, Triptychs, etc. may be entered as one work. Use the form below and also place label with name, title and price on back of paintings and under sculptures. Sculptures over 50 lbs. are to be installed by artist. Installations must meet fire and safety codes and free standing work stable and safe for viewing. Award winners are solely at the Judge's discretion.

**LIABILITY:**

The Sacramento Fine Arts Center will be diligent in care of artwork but is not responsible for loss or damage that might occur. Insurance is the responsibility of each artist

**COMMISSION:**

SFAC will retain commissions on work sold. 30% members, 10% youth.

**REMOVING WORK:**

Accepted work must remain for the duration of the show and will only be released at end of exhibit January 27th at 5:00 pm.

**STORAGE FEES:**

Work left after one week after exhibit closes will be assessed \$5.00 per day per work. Work left after one month, becomes property of the Sacramento Fine Arts Center.

**AGREEMENT:** I have read and agree to abide by all exhibit rules. I waive any and all claims against the Sacramento Fine Arts Center and individuals associated with the exhibition. Submitted art is my original work and has never been shown at SFAC. My work will be removed Sunday, January 27, 2019 between 5:00 and 6:00 pm or the following week during open hours.
