Any work containing objectionable material will be rejected. Care will be taken in the handling of your art but neither the Sacramento Fine Arts Center or its members shall be held responsible for any liabilities arising from this exhibit.

Do not enter work previously shown in an SFAC juried show . Each photograph must be framed, or otherwise ready for hanging, and wired with braided or coated wire. Wire ends must be taped. Saw-tooth hangers will not be accepted. No copies of commercially published works. All work must be for sale. All work shall be labeled on the reverse with artist's name, phone and the title and sale price of the piece. Call the SFAC office at 916.971-3713 for additional information.

ENTRIES WILL BE ACCEPTED IN THE FOLLOWING SIX CATEGORIES:

(1.Landscape/Nature), (2.Animals), (3. People), (4.Photo Art/Manipulated), (5.Other) and (6.Youth, 17 and younger).

FEES (non-refundable): Adult: \$15 for each photograph or 3 for \$40. Junior: \$10 or 3 for \$25. No limit.

SALES COMMISSION: 50% non-member or 30% member of any exhibit sales will be taken and handled by the Sacramento Fine Arts Center.
