Open Juried Exhibition of Paintings of the American River Parkway and its Wild Things

REQUIREMENTS: Open to all artists 16 and older. Subject matter must be American River Parkway and the plants and animals that are native to it. Entry fee \$15 per artwork, limit 3 artworks (non-refundable). Submit only recent work, finished within the last two years. All artwork must be for sale. Work must be original artwork not previously shown at Sacramento Fine Arts Center (SFAC). Watermedia, Oil/Acrylic/Soft Pastel, Graphics/Pencil/Pen & Ink/Hard Pastel, Mixed Media, Textile and Sculpture. No Photography. No copies, no class or workshop artwork, crafts or work by any commercial printing process or video/film. No giclees. **SIZE LIMIT:** 36" outside dimension in width and 48" in height. Work with glass must have rigid gallery style framing. We suggest plain frames with neutral mats. Work exceeding 29" X 35" (1015 sq. inches) must use plastic instead of glass glazing. No unfinished canvas edges, protruding nails, staples or saw-tooth hangers. Use braided wire and flat brackets or screw eyes to attach wire. Tape wire ends. Diptychs, Triptychs, etc. must be connected, wired and ready to hang. On left side back of artwork attach provided tag. Three dimensional and assembled works must be stable and safe for viewing. The artist may be called to assist installation on extremely heavy works. **SELECTION AND SALES:** The judge will select artwork for the show from the entries. Each accepted artist receives 1 Gala ticket. After the exhibit at SFAC the selected unsold artwork will be transferred to the Gala and Auction at Effie Yeaw Nature Center (EYNC) and will be sold at live and silent auctions. Bids will begin at 40% of stated price. Artists will split sale 50/50 with ARNHA for EYNC at Gala.

REMOVING WORK: Non-accepted work must be picked up at SFAC by May 12, 2012. Notification of accepted work will be posted at www.sacfinearts.org. Accepted work must remain for the duration of the show. At the end of the exhibit at SFAC, works will be transferred to the EYNC for display and auction at the Gala Event June 9, 2012. Unsold work from the Gala and Auction will be released at end of exhibit and should be picked up at EYNC the following week. **STORAGE FEES:** Non-accepted work left after May 19, 2012 will be assessed \$5.00 per day per work. Work left after one month becomes the property of SFAC. **STATEMENT OF LIABILITY:** The Sacramento Fine Arts Center and ARNHA (Effie Yeaw Nature Center) will be diligent in care of artwork but is not responsible for loss or damage that might occur. Insurance is the responsibility of each artist. Any work containing unacceptable materials may be withdrawn by the SFAC and the ARNHA Board of Directors. **SFAC SHOW CHAIR: DAVID PETERSON: 916.716.5951. EYNC GALA QUESTIONS 916.489.4918.**
